#### DIRECTIONS TO 247 CALICOE DR. AKRON

#### From north of Akron:

From Rt. 8 you can go to the central interchange and follow I-76 West toward Barberton. The third exit is Dart Ave. Exit at Dart turning right at the bottom of the exit. Follow Dart (it parallels the inner-belt) to the second traffic signal which is Bartges. Turn right then right at the first street, La Salle. Turn left at the next street which is Calicoe. 247 is the first unit on the left.

#### From east or south of Akron:

From Rt. 8 you can go to the central interchange and follow I-76 West. The third exit is Dart Ave. Exit at Dart turning right at the bottom of the exit. Follow Dart (it parallels the inner-belt) to the second traffic signal which is Bartges. Turn right then right at the first street, La Salle. Turn left at the next street which is Calicoe. 247 is the first unit on the left.

From west of Akron:

Exit at the Lakeshore / Bowery exit. Go to the traffic signal and turn left. Follow the street, Dart, as it curves and parallels the inner-belt. At the third traffic signal, Bartges, turn right. Turn right at the first street, La Salle, and then left at the next, Calicoe. 247 is the first unit on the left.

PARKING IS ALLOWED ONLY ON THE PARKING PADS AT EACH END OF CALICOE. YOU MAY ALSO PARK ON THE RIGHT SIDE OF LA SALLE. PARKING ON LA SALLE IS NOT VERY FAR FROM MY HOUSE. JUST CROSS THE STREET AND WALK UP CALICOE.
